REQUEST FOR BID- (RFB) - Quest, Inc.

Orlando, Florida (October 9, 2020) Life Concepts, Inc. dba Quest, Inc. is currently soliciting bids from suitably qualified and experienced firms with the intent to make renovations at the Laurel Hill Cluster. These renovations are to include construction of interior improvements.

The proposed project is funded by Quest and an Orange County Community Development Block Grant (CDBG). The project must meet and/or exceed the standards of the ADA and be in accordance with Federal Community Development Block Grant programs, as may be amended and other application laws and regulations.

Bids will be considered from professional firms that demonstrate experience and success in conducting master planning and renovations for ADA facilities as well as adhering with all applicable federal requirements as stated in the special provisions including the Davis-Bacon Act. The winning bidder must obtain registration with Sam.gov, have an active DUNS number and Sunbiz.org for the same business entity in compliance with state and federal requirements prior to a contract being signed.

Procurement is by sealed bid. Bids are publicly solicited and a firm-fixed price contract is awarded to the responsive bidder whose bid, conforming to all the material items and conditions of the invitation for bids, is the lowest and/or most responsive bid.

A mandatory pre-bid meeting and tour to discuss the project will be held on October 15, 2020 at 10:30 a.m. at Laurel Hill Cluster, 2011 Laurel Cluster Ct., Orlando, FL 32818. Any contractors interested in submitting a bid must attend the entire meeting and tour on this day.
